Iris reported provided an update on the mold remediation project:

Paul Davis will work as the lead contractor on the project with Anissa Construction working as a subcontractor. Based on this arrangement, Paul Davis will submit a new scope of work.

Under a worst-case scenario, the third, fourth, fifth, and sixth grades will not be able to use the classrooms in the affected building at the beginning of the school year. However, it is predicted that the third grade and possible the fourth grade classes will be in their regular classrooms at the beginning of the school year. Staff have volunteered to move classrooms out of the building and set them up in alternate spaces.

The remediation and water diversion projects are complicated due to the presence of gas, electric, and water lines. However, the team is working closely with architects and engineers to identify solutions.

Paul Davis will also address the water leaks recently discovered in the front building.
